OF THE

HOUSE OF REPRESENTATIVES.

THURSDAY, 1st OCTOBER, 1903.

1. The House met pursuant to adjournment.-Mr. Speaker took the Chair, and read Prayers.

- 2. PETITION.—Mr. Watson presented a Petition from certain employers of labour in Queensland, praying that the House will preserve the principle of voluntary agreement or conciliation between employer and employé, or submit the Conciliation and Arbitration Bill to the consideration of the electors of Queensland and the Commonwealth. Petition received.
- 3. SEAT OF GOVERNMENT BILL.—Sir William Lyne moved, by leave, That leave be given to bring in a Bill for an Act to determine the Seat of Government of the Commonwealth. Question—put and resolved in the affirmative. Ordered—That Sir William Lyne do prepare and bring in the Bill.
- APPROPRIATION BILL 1903-4.—The Order of the Day for the third reading of this Bill having been read—Sir George Turner moved, That the Bill now be read a third time. Debate ensued.

- 6. SEAT OF GOVERNMENT BILL.—Sir William Lyne, pursuant to an Order of the House, made this day, brought up a Bill intituled "A Bill for an Act to determine the Seat of Government of the Commonwealth," and moved, That it be now read a first time.
 Question—put and resolved in the affirmative.—Bill read a first time.
 Ordered—That the second reading be made an Order of the Day for Tuesday next.
- 7. WAYS AND MEANS RESOLUTIONS.—The Order of the Day for the consideration of certain resolutions reported from the Committee of Ways and Means having been read—the said resolutions were read, and are as follow:—

SUPPLEMENTARY ESTIMATES, 1901-2 AND 1902-3.

Resolved—That towards making good the further Supply granted to His Majesty for the services of the period ended 30th June, 1901, and the year ended 30th June, 1902, a sum not exceeding Six thousand nine hundred and sixty-eight pounds be granted out of the Consolidated Revenue Fund.

Resolved—That towards making good the further Supply granted to His Majesty for the services of the year ended 30th June, 1903, a sum not exceeding One hundred and seven thousand nine hundred and ninety-seven pounds be granted out of the Consolidated Revenue Fund.

SUPPLEMENTARY ESTIMATES, 1901-2 AND 1902-3, FOR ADDITIONS, NEW WORKS, AND BUILDINGS.

Resolved-That towards making good the further Supply granted to His Majesty for Additions, New Works, and Buildings for the year ended 30th June, 1902, a sum not exceeding One thousand and four pounds be granted out of the Consolidated Revenue Fund.

Resolved—That towards making good the further Supply granted to His Majesty for Additions, New Works, and Buildings for the year ended 30th June, 1903, a sum not exceeding Two thousand six hundred and thirty-five pounds be granted out of the Consolidated Revenue Fund.

And the said resolutions were adopted by the House.

Question-put and resolved in the affirmative.-Bill read a first time.

Sir George Turner moved, That the Bill be now read a second time. Question—put and resolved in the affirmative.—Bill read a second time. Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Deputy Speaker took the Chair; Mr. McDonald reported that the Committee had gone through the Bill and agreed to the same with amendments.

Ordered That the consideration of the Report be made an Order of the Day for Tuesday next.

11. SPECIAL ADJOURNMENT.-Mr. Deakin moved, That the House, at its rising, adjourn until Tuesday next.

Question—put and resolved in the affirmative.
