- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. PRECEDENCE TO GOVERNMENT BUSINESS FOR PORTION OF SITTING.—Mr. Bruce (Prime Minister) moved,
 That the Sessional Order governing the order of Business be suspended for this day, and that
 Government Business be given precedence over General Business for this sitting until after the
 delivery of the Budget Statement, and that General Business be proceeded with this evening for
 an additional time equivalent to that occupied by the delivery of the Budget Statement.
 Debate ensued.

Question—put and passed.

- 3. Postponement of Order of the Day.—Ordered—That Order of the Day No. 1, Government Business, be postponed until after Order of the Day No. 2.
- 4. Messages from the Governor-General.—Estimates, 1926-27.—The following Messages from His Excellency the Governor-General were presented, and the same were read by Mr. Speaker:—

7. WAYS AND MEANS [CUSTOMS TARIFF AMENDMENT (No. 2)].—The House, according to Order, resolved itself into the Committee of Ways and Means.

Mr. Pratten (Minister for Trade and Customs) moved—

That the Schedule to the Customs Tariff 1921–1926 be amended as hereunder set out, and that on and after the Ninth day of July, One thousand nine hundred and twenty-six, at Nine o'clock in the forenoon, Victorian time, Duties of Customs be collected in pursuance of the Customs Tariff as so amended.

That, excepting by mutual agreement or until after six months' notice has been given to the Government of the Dominion of New Zealand, nothing in this Resolution shall affect any goods entering the Commonwealth of Australia from the Dominion of New Zealand.

11. PARLIAMENT HOUSE, CANBERRA-REFRESHMENT BAR .- Sir Elliot Johnson moved, pursuant to notice. That this House disagrees with that portion of the Report of the Joint House Committee which advocates the retention of the refreshment bar for Federal Parliament House, at Canberra, and considers that it should be subject to the same conditions as to the sale of intoxicants which apply to the Federal Territory generally.

Debate ensued.

Mr. McGrath addressing the House, and not having concluded his speech, asked leave to continue his speech when the debate is resumed.

Objection being raised, leave not granted.

The time allotted for precedence to Notices of Motion, General Business, having terminated, Orders of the Day, General Business, were called on.

12. MINISTERIAL STATEMENT-REFERENDUMS.-Mr. Bruce (Prime Minister), by leave, informed the House that the dates to be fixed in connexion with the submission to the electors of the proposed laws for the alteration of the Constitution in relation to Industry and Commerce, and Essential Services, would be as follow:-

Date of Polling-Saturday, 4th September, 1926.

Return of Writs-On or before Tuesday, 12th October, 1926.

13. RAILWAY THROUGH CENTRAL QUEENSLAND TO NORTH-SOUTH LINE.—The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Manning:—That it is essential for the proper development of Northern Australia that a railway be constructed from Bourke, New South Wales, through Central Queensland towards Cloncurry and thence across the Barkly Tablelands to a point on the North-South Railway in the Northern Territory the carrying of this resolution to be taken as an instruction from this House to the Government to approach the State Governments of New South Wales and Queensland with a view of apportioning the expense of constructing this line between the Commonwealth and the States mentioned—And on the Amendment moved thereto by Mr. Gregory, viz.:—Omit all the words after "constructed from" up to and inclusive of the words "Northern Territory" and insert in place thereof, "Broome or Derby starting in an easterly direction up to its junction with the North-South railway at or about Newcastle Waters, thence south of east to Camooweal"— Debate resumed.

Mr. Lister moved, That the debate be now adjourned.

Question - That the debate be now adjourned—put and passed.
