- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. Papers.—The following Papers were presented, by command of His Excellency the Governor-General—Federal Health Council of Australia—First Session, held at Melbourne from 25th to 28th January, 1927—Report.

- 3. League of Nations—Seventh Assembly—Report of Australian Delegation—Printing of Paper.—Mr. Latham (Attorney-General), a delegate of the Commonwealth at the Assembly, laid upon the Table, by command of His Excellency the Governor-General, the Report of the Australian Delegation to the Seventh Assembly of the League of Nations (6th September to 25th September, 1926)—and, after giving a Report of the Proceedings at the Conference, moved, That the Paper be printed.
 - Mr. Latham not having concluded his speech at the termination of the time allowed by Standing Order No. 257A, the honorable Member was given leave to continue his speech.

Mr. Manning, who was also a delegate of the Commonwealth at the Assembly, also gave an account of the proceedings.

- (1) That, with reference to the Resolution agreed to by the Senate on the 3rd March, 1927, the following Senators be appointed to serve on the Joint Committee to inquire into and report on the moving-picture industry in Australia:—Senators Duncan, Grant, and Herbert Hays;
- (2) That one Member of the Senate, sitting with three other Members of the Committee, shall constitute a quorum, provided that in such quorum both Houses shall be represented;
- (3) That the Committee have leave to report the Minutes of Evidence from time to time;
 (4) That the Senate agrees to the time and place proposed by the House of Representation
- (4) That the Senate agrees to the time and place proposed by the House of Representatives for the first meeting of the Committee.

5. Message from the Governor-General.—Supply Bill (No. 1) 1927-28.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:-

Governor-General.

Message No. 58.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to grant and apply a sum out of the Consolidated Revenue Fund for the service of the year ending the thirtieth day of June, One thousand nine hundred and twenty-eight.
