- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. Message from the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was received, and the same was read by Mr. Speaker:—

A Bill intituled "Commonwealth Housing Act 1928," as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Act.

3. Martin Electoral Division—Issue of Writ.—Mr. Speaker announced to the House that he proposed to issue a Writ, on Thursday, the 24th instant, for the Election of a Member to serve for the Electoral Division of Martin, in the State of New South Wales, in the place of the Honorable Herbert Edward Pratten, deceased. The dates in connexion with the Election would be fixed as follows:—

Date of Issue of Writ ... Thursday, 24th May, 1928.
Date of Nomination ... Tuesday, 5th June, 1928.
Date of Polling ... Saturday, 16th June, 1928.

Date for Return of Writ On or before Wednesday, 27th June, 1928.

- 5. MINISTERIAL STATEMENT—APPOINTMENT OF ROYAL COMMISSION—ALLEGED MONETARY OFFERS TO MEMBERS.—Mr. Bruce (Prime Minister), by leave, made a Ministerial Statement announcing that the Government had decided to ask the Chief Justice of the High Court of Australia to act as a Royal Commissioner to inquire into certain statements made through the press by Mr. W. H. Lambert, M.P., and the Honorable G. Cann, to the effect that monetary offers had been made to certain Members of the House of Representatives to induce them to resign their seats in the House.
- Mr. Theodore, Mr. Anstey and Mr. Scullin (Leader of the Opposition), by leave, also made Statements with reference to the matter.
- 6. WINE EXPORT BOUNTY BILL (1928).—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Clause 3 further debated-

On the motion of Mr. Gullett, the following proviso was added to the clause, after debate:-

"Provided that no bounty shall be payable in respect of wine which is not shown, to the satisfaction of the Minister, to be the product of areas planted with vines on or before the thirty-first day of March One thousand nine hundred and twenty-eight."

Question—That the clause, as amended, be agreed to—put.

And so it was resolved in the affirmative.

New Clauses-

Mr. Thomas Paterson (Minister for Markets) moved, That the following new clause be added to the Bill:

twithstanding anything contained in this Act, the rate of bounty by abountles to apply to existing contracts, and to shipments to Canada. 4. Notwithstanding anything contained in this Act, the rate of bounty payable:-

- shipped in Australia on or before the thirty-first day of December One thousand nine hundred and twenty-eight, in fulfilment of a contract in writing which is proved to the satisfaction of the Minister to have been entered into on or before the eighth day of March One thousand nine hundred and twenty-eight, and to be still subsisting;
- (b) in respect of wine shipped in Australia on or after the ninth day of March One thousand nine hundred and twenty-eight, in respect of which a notice of intention to export was given, as prescribed, on or before the eighth day of March One thousand nine hundred and twenty-eight; and
 (c) in respect of wine shipped to the Dominion of Canada, which the Minister is satisfied
- is intended for consumption in that Dominion,

shall, subject to the provisions of the Principal Act, be one shilling and ninepence per gallon.

Mr. R. W. Foster moved, as an amendment, That the word "twenty-eight" (first occurring) be omitted, and the word "twenty-nine" be inserted in place thereof.

Temporary Chairman's Ruling .- The Temporary Chairman (Mr. Mann) ruled the amendment out of order on the ground that it was not covered by the terms of the Governor-General's recommendation.

Mr. Parsons moved, That the new clause be postponed.

Dissent from Temporary Chairman's Ruling.—Mr. Gregory having moved, That the Temporary Chairman's Ruling, in refusing to accept Mr. R. W. Foster's proposed amendment, be dissented

Point of Order-Temporary Chairman's Ruling.-A point of order was raised by Mr. Latham (Attorney-General), that dissent from the ruling should have been moved forthwith. The Temporary Chairman ruled that as Standing Order No. 228 provides that objection to a ruling must be stated at once, in writing, it was now too late to dissent.

Question—That the new clause be postponed—put and negatived. Question—That the new clause be added to the Bill—put and passed.

On the motion of Mr. Thomas Paterson, the following new clause was added to the Bill, after debate:-

5. This Act shall be construed, and read as one, with the Principal Act.

Title agreed to. Bill to be reported with amendments.

The House resumed; Mr. Mann reported accordingly.

On the motion of Mr. Thomas Paterson, the House, by leave, adopted the Report, and, by leave, the Bill was read a third time.

8. ADJOURNMENT.—Mr. Bruce (Prime Minister) moved, That the House do now adjourn. Debate ensued.

Question—put and passed.

And then the House, at twenty-five minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
