- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.-Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. PAPER.-The following Paper was presented, pursuant to Statute-

- 3. THE LATE HONORABLE HERBERT EDWARD PRATTEN.-Mr. Speaker informed the House that he had received from Mr. H. G. Pratten, a son of the late Honorable Herbert Edward Pratten, a letter, on behalf of his mother, thanking the House for its resolution of sympathy.
- 4. MESSAGE FROM THE SENATE. DRIED FRUITS BILL .- Mr. Speaker announced the receipt of the following Message from the Senate :---

8. MESSAGE FROM THE GOVERNOR-GENERAL.-AUSTRALIAN BRITISH EMPIRE EXHIBITION BILL.-The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker :-

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the holding of an Exhibition in Australia.

The Resolution reported from the Committee was read, and, on the motion of Mr. Bruce, was adopted by the House.

Ordered-That Mr. Bruce and Mr. Latham do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Bruce then brought up the Bill accordingly, and moved, That it be now read a first time.

Question-put and passed.-Bill read a first time.

Ordered-That the second reading be made an Order of the Day for a later hour this day.

9. DRIED FRUITS BILL .- SENATE'S AMENDMENTS .- The Order of the Day having been read for the consideration in Committee of the whole House of the Amendments made by the Senate in this Bill-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

The House resumed; Mr. Bayley reported accordingly.

On the motion of Mr. Thomas Paterson, the House adopted the Report.

Question—That the debate be now adjourned—put and passed. Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

11. ADJOURNMENT.-Mr. Bruce (Prime Minister) moved, That the House do now adjourn. Debate ensued. Question—put and passed.
