# VOTES AND PROCEEDINGS

## HOUSE OF REPRESENTATIVES.

#### WEDNESDAY, 12TH SEPTEMBER, 1928.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment .-- Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. WEST SYDNEY ELECTORAL DIVISION .- PROPOSAL NOT TO ISSUE WRIT.---Mr. Speaker made the following statement to the House :---

As honorable Members are aware, a vacancy has occurred in the representation of the Electoral Division of West Sydney. It has been announced in this House that a dissolution of the House will be sought at an early date with a view to the holding of the General Election on Saturday, 17th November next.

I have made careful inquiry and I find that if a Writ were issued and the shortest reasonable periods allowed between the issue of the Writ and the nominations, and between the nominations and the polling, it is almost certain that the Session would have concluded and the dissolution of the House have taken place before the date of polling.

Therefore, I do not at present propose to issue a Writ, under existing circumstances, for the vacant Division.
