- 1. The House met, at eleven o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable Sir Littleton Groom) took the Chair, and read Prayers.
- 2. THE LATE SENATOR THOMAS GIVENS.—Mr. Speaker informed the House that he had received from Mrs. Givens, widow of the late Senator Thomas Givens, a letter thanking the House for its resolution of sympathy.
- 3. Message from the Governor-General.—Assent to Bills.—The following Message from His Excellency the Governor-General was received, and the same was read by Mr. Speaker:—

5. INCOME TAX ASSESSMENT BILL (1928).—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—Debate resumed.

Question—put and passed.—Bill read a second time.

Clause 6-

On the motion of Mr. Earle Page, the following amendments were made:-

Page 3, line 29, after "amended" insert "-(a)".

Page 3, line 32-33, omit ", except where the member or shareholder is a company,". Page 3, line 34, omit " does not exceed ", insert " is less than ". Page 3, line 36, omit " in his assessment".

Page 3, line 38, after "assessment:" insert "; and (b) by omitting from the second proviso following sub-paragraph (iii) of paragraph (b) the words 'in his assessment'".

Clause, as amended, agreed to.

Clause 7 debated.

Mr. Duncan-Hughes moved, as an amendment, That the word "not" (line 20) be omitted.

Debate continued.

Amendment negatived.

Clause agreed to.

Clause 8

On the motion of Mr. Earle Page, the following amendment was made, after debate :-

Pages 4-5, omit proposed sub-sections (5.) and (6.), insert the following proposed sub-section:—

(5.) For the purpose of ascertaining the taxable income of a company the principal business of which is life insurance there shall be excluded from the assessment the following amounts-

- (a) all premiums received in respect of policies of life insurance and all considerations received in respect of annuities granted and all income derived from any source whether in or outside Australia which, apart from the provisions of this sub-section, would not be included in the assessment, and all expenditure exclusively incurred in gaining those premiums or considerations or that income; and
- b) the part of the expenditure incurred in the general management of the business of the company (but not including any expenditure exclusively incurred in gaining or producing the income included in the assessment) which bears to that expenditure the proportion which the sum of the premiums, considerations and income mentioned in paragraph (a) of this sub-section bears to the total income of the company derived from any source whether in or outside Australia.".

Question—That the clause, as amended, be agreed to—put.

Progress to be reported, and leave asked to sit again.
