Amendment negatived.

Question—That the motion be agreed to—put and passed.

Resolution to be reported, and leave asked to sit again.

The House resumed ; Mr. McGrath reported accordingly.

SCHEDULE OF THE AMENDMENTS MADE BY THE SENATE.

No. 1.-Page 2, clause 2, after sub-section (4.) of proposed section 7 m insert the following new sub-section :-

"(5.) The provisions of sub-sections (1.) and (2.) of this section shall not apply in respect of gold held by any State Savings Bank."

No. 2.—Page 2, clause 2, leave out sub-section (3.) of proposed section 7c.

No. 3.--Page 2, clause 2, leave out sub-section (4.) of proposed section 7c, insert the following new sub-section :-

"7E. Sections 7B and 7c of this Act shall remain in operation until the thirtieth Duration of operation. of December One thousand nine hundred and thirty and no longer." day

Reason for Disagreeing to Amendment No. 1.—As one of the objects of the Bill is the mobilization of the whole of the gold resources of Australia in case of necessity, and as this objective could not be attained if Savings Banks or any other institutions were excluded from the provisions of the Bill, it is undesirable that Savings Banks should be so excluded.

Reason for Disagreeing to Amendment No. 4 .- As any proclamation relating to the export of gold will be made only after the receipt of a recommendation from the Board, and as any such proclamation will indicate the period for which it is to remain in force, and as the necessity for action under the Bill may arise after the thirtieth day of December One thousand nine hundred and thirty, it is undesirable to limit the operation of the Act to any specific period.

Mr. Theodore moved, That the Committee's Reasons be adopted.
