The Resolution reported from the Committee was read, and, on the motion of Mr. Fenton, by leave,

was adopted by the House. Ordered—That Mr. Fenton and Mr. Blakeley do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Fenton then brought up the Bill accordingly, and moved, That it be now read a first time. Question-put and passed.-Bill read a first time.

Ordered-That the second reading be made an Order of the Day for the next sitting.

- 19. POSTPONEMENT OF ORDER OF THE DAY .- Ordered-That Order of the Day No. 3 be postponed until after Order of the Day No. 4, Government Business.
- 20. IMMIGRATION BILL (1930).-The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time. Debate resumed.

Question-put and passed --- Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.
