- 2. PRIVILEGE-NEWSPAPER REFLECTIONS UPON MR. SPEAKER.-Mr. Bayley complained to the House of certain statements in the South Australian Worker newspaper as a breach of privilege, and having produced a copy of the paper containing the statements in question and given the name of the publisher thereof, moved, That the comments of the South Australian Worker on the actions of the honorable the Speaker and his control of the business of this House are gross and malicious misrepresentations of the facts, and that the editor of the South Australian Worker and the publisher, Douglas Henry Bardolph, are guilty of contempt.
