#### THURSDAY, 29TH OCTOBER, 1931.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable Norman J. O. Makin) took the Chair, and offered Prayers.
- 2. DEATH OF THE HONORABLE P. McM. GLYNN.—Mr. Scullin (Prime Minister) moved, by leave, That the sympathy of this House be extended to the members of the family of the late Honorable Patrick McMahon Glynn, K.C., who, from the date of his election to the first Commonwealth Parliament until 1919, was a Member of the House of Representatives, and rendered outstanding service to Australia as a Member of the Legislature and as a Minister of the Crown.

And Mr. Latham (Deputy-Leader of the Opposition) having seconded the motion, and all Members present having risen in silence-

- Question--passed.

  Resolved--That Mr. Speaker be requested to transmit to the members of the family of the late Honorable P. McM. Glynn the foregoing Resolution together, with a copy of the speeches delivered thereon.
- 3. WIMMERA BY-ELECTION.—Mr. Speaker informed the House that he had this day issued the Writ in connexion with the By-election for the Wimmera Division, and that the dates fixed were those announced to the House on Tuesday, the 20th instant.
- 4. Correction of Error in Division List.—Mr. Speaker informed the House that in the first Division taken on Tuesday, the 20th instant, the Tellers inadvertently made an error. The name of Mr. Theodore should have been included in the List of those Members who voted with the Noes, instead of the name of Mr. Thompson. The error would be rectified in the official records.

Mr. Parkhill moved, as a further amendment, That the words "in such manner as is prescribed" (page 2, line 11) be omitted and that the following words be inserted in place thereof "in proportion to the interests of the share-farmers in the wheat or the proceeds thereof".

Clause 7 agreed to.

Clause 8 debated and agreed to.

Clause 9-

Page 2, line 31, omit "in relation to wheat".

Page 2, line 32, after "necessary" insert "in relation to compliance with this Act or the regulations made thereunder or any suspected contravention thereof".

Clause, as amended, agreed to.

Clauses 10 and 11 agreed to.

Preamble agreed to.

Title agreed to.

No. 1.—Page 2, clause 3, lines 4 and 5, leave out "from time to time, by notice published in the Gazette, fix", insert "by regulation, prescribe".
No. 2.—Page 2, clause 3, lines 9-11, leave out "under any one or more of the laws of any State

imposing taxes upon incomes whether for a specified purpose or not", insert "-

(a) under any one or more of the laws of any State imposing taxes upon incomes for the purposes of the general revenue of the State, and

(b) under any one or more of the laws of any State imposing taxes upon incomes, where the law of the State expressly provides that the revenue received from the tax is to be applied to meet expenditure incurred by the State for any special purpose, or the regulations prescribe that, for the purposes of this section, the tax shall be deemed to be a tax to meet expenditure incurred by the State for a special purpose".

No. 3.—Page 2, clause 3, line 12, leave out "publication in the Gazette", insert "making".

No. 4.—Page 2, clause 3, line 12, leave out "a notice", insert "regulations".

No. 5.—Page 2, clause 3, line 16, leave out "notice", insert "regulations".

No. 6.—Page 2, clause 3, line 17, leave out "that fixed in the notice", insert "is prescribed".

No. 7.—Page 2, clause 3, line 19, leave out "fix", insert "prescribe".

On the motion of Mr. Theodore (Treasurer), the Amendments were agreed to, after debate. Resolution to be reported.
