1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. H. Mackay) took the Chair, and read Prayers.
2. MINISTERIAL STATEMENT—DAYS OF SITTING AND EASTER ADJOURNMENT.—Mr. Lyons (Prime Minister), by leave, made a Ministerial Statement announcing that he proposed to ask the House to sit after next week on Tuesday, Wednesday, Thursday and Friday of each week, and to adjourn on the 18th March for three or four weeks.
3. WAR SERVICE HOMES BILL (1932).—Mr. Josiah Francis (Minister administering War Service Homes) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend sections thirty-one, thirty-six and forty-three of the *War Service Homes Act 1918-1929*.  
Question—put and passed.  
Mr. Josiah Francis then brought up the Bill accordingly, and moved, That it be now read a first time.  
Question—put and passed.—Bill read a first time.  
Ordered—That the second reading be made an Order of the Day for the next sitting.
4. FINANCIAL AGREEMENT ENFORCEMENT BILL.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—  
Debate resumed.  
Mr. Holman not having concluded his speech at the termination of the time allowed by Standing Order No. 257B—  
Ordered—That the honorable Member have leave to continue his speech.  
Debate continued.  
Mr. Rosevear not having concluded his speech at the termination of the time allowed by Standing Order No. 257B—  
Ordered—That the honorable Member have leave to continue his speech.  
Debate continued.  
Mr. E. J. Harrison moved, That the debate be now adjourned.  
Question—That the debate be now adjourned—put and passed.  
Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

Wine Overseas Marketing Act—Regulations Amended—Statutory Rules 1932, No. 18.
6. ADJOURNMENT.—Mr. Lyons (Prime Minister) moved, That the House do now adjourn.  
Debate ensued.  
Question—put and passed.

And then the House, at ten minutes past four o'clock p.m., adjourned until Wednesday next at three o'clock p.m.
