- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. H. Mackay) took the Chair, and read Prayers.
- 2. War Service Homes Bill (No. 2) (1932).—Mr. Josiah Francis (Minister administering War Service Homes), pursuant to leave given on the 1st September last, brought up a Bill intituled "A Bill for an Act to amend section twenty-nine of the 'War Service Homes Act 1918-1929', as amended by the 'War Service Homes Act 1932'", and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Ordered—That the second reading be made an Order of the Day for the next sitting.

3. Papers.—The following Papers were presented, by command of His Excellency the Governor-General—Nauru—Report to the Council of the League of Nations on the Administration of Nauru during the year 1931.

WAR SERVICE HOMES AGREEMENT BILL (1932).—Mr. Josiah Francis (Minister administering War Service Homes) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to approve an Agreement between His Majesty's Government of the Commonwealth of Australia and the Commissioners of the State Savings Bank of Victoria and for other purposes. Question—put and passed.
- 5. Message from the Governor-General.—Financial Relief Bill.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:—

In accordance with the requirements of Section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of Revenue be made for the purposes of a Bill for an Act to reduce Taxation; to remove anomalies in relation to Invalid and Old-age Pensions; to provide Financial Relief for Wheat Growers and other Primary Producers; and for other purposes.

Ordered, after debate—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Mr. Lyons (Prime Minister) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to reduce Taxation; to remove anomalies in relation to Invalid and Old-age Pensions; to provide Financial Relief for Wheat Growers and other Primary Producers; and for other purposes.

Question—put and passed. Resolution to be reported.

The House resumed; Mr. Bell reported accordingly.

Mr. Lyons moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

The Resolution reported from the Committee was read, and, on the motion of Mr. Lyons, was adopted by the House.

Ordered-That Mr. Lyons and Mr. Guy do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Lyons then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time. Mr. Lyons moved, That the Bill be now read a second time.

Debate ensued.

Suspension of sitting.—At five o'clock p.m., Mr. Speaker left the Chair. Resumption of sitting.—At eight o'clock p.m., Mr. Speaker resumed the Chair.

Debate continued.

Mr. Prowse moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.
