- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. J. Bell) took the Chair, and read Prayers.
- 2. MINISTERIAL STATEMENT—TRADE AGREEMENT WITH BELGIUM—PRINTING OF PAPER.—Mr. White (Minister for Trade and Customs), by leave, made a Ministerial Statement announcing a Trade Agreement between the Commonwealth of Australia and Belgium, and, by command of His Excellency the Governor-General, laid upon the Table the following Paper—

- 3. MINISTERIAL STATEMENT—ALLEGED UNAUTHORIZED POSSESSION OF ARMS, ETC.—Mr. Parkhill (Minister for Defence), by leave, made a Ministerial Statement with regard to the alleged possession by unauthorized organizations in the Commonwealth of rifles, machine guns, ammunition, &c.
- 4. MINISTERIAL STATEMENT—AUSTRALIAN CONVERSION LOAN IN LONDON.—Mr. Casey (Assistant Treasurer), by leave, made a Ministerial Statement announcing the over-subscription of the recent Australian Conversion Loan in London.
- 5. The Late King Albert of Belgium.—Mr. Speaker informed the House that a reply had been received from the Belgian Government, conveying the thanks of the Government and people of Belgium, and deeply appreciating the expression of sympathy contained in the Resolution which was passed by the House of Representatives on the 28th June last.
- 6. THE LATE SIR ROBERT GIBSON.—Mr. Speaker informed the House that he had received from Lady Gibson a letter thanking the House for its Resolution of Sympathy passed on the 28th June last.
- 7. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Beasley rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The need for immediate legislation to prevent the further exploitation of the people of Australia by the Colonial Sugar Refining Company Limited".

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—Mr. Beasley moved, That the House do now adjourn.

9. Message from the Governor-General.—Appropriation (Works and Services) Bill.—The following Message from His Excellency the Governor-General was presented, and the same was read by Mr. Speaker:—

ISAACS A. ISAACS,

Governor-General.

Message No. 4.

In accordance with the requirements of section 56 of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of Revenue be made for the purposes of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund a sum of One hundred and seventy-six thousand pounds for the purpose of Expenditure on certain Works and Services.

Canberra, 21st November, 1934.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

Mr. Casey (Assistant Treasurer) moved, That it is expedient that an appropriation of Revenue be made for the purposes of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund a sum of One hundred and seventy-six thousand pounds for the purpose of Expenditure on certain Works and Services.

Question—put and passed. Resolution to be reported.

The House resumed; Mr. Prowse reported accordingly.

Mr. Casey moved, pursuant to contingent notice, That the Standing Orders be suspended, to enable the remaining stages to be passed without delay.

Question—put and passed.

The Resolution reported from the Committee was read, and, on the motion of Mr. Casey, was adopted by the House.

Ordered—That Mr. Casey and Mr. Thomas Paterson do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Casey then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Casey moved, That the Bill be now read a second time.

Debate ensued.

Mr. Ward moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

10. Adjournment.—Mr. Menzies (Attorney-General) moved, That the House do now adjourn. Question—put and passed.

And then the House, at three minutes past eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
