- 3. SUPPLY BILL (No. 2) 1935-36.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House-Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Part I .-- Departments and Services-Other than Business Undertakings and Territories of the Čommonwealth, £1,718,550—further debated.

- "Miscellaneous Services, £110,510"—agreed to. "War Services, £249,750"—
