Places on record its high appreciation of the unique and valuable services extending over many years rendered by Sir Charles Kingsford Smith to civil aviation in Australia, not only by his many brilliant pioneer and record-breaking flights, but by his activities in connexion with the operation of regular air transport services and the maintenance of a flying training organization;

Tenders to the widows and families of the missing airmen its profound sympathy in the irreparable loss they have sustained; and

Thanks all Governments, civil organizations, officials and other persons who assisted in carrying out the comprehensive air and ground searches made for the missing airmen.

And Mr. Curtin (Leader of the Opposition) having seconded the motion, and other honorable Members having addressed the House in support thereof, and all Members present having risen, in silence—Question—passed.
