- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable G. J. Bell) took the Chair, and read Prayers.
- 2. ALTERATION OF HOUR OF NEXT MEETING.-Mr. Menzies (Prime Minister) moved, That the House, at its rising, adjourn until half-past ten o'clock a.m. to-morrow. Question—put and passed.
- 3. PAPERS.—The following Paper was presented, by command of His Excellency the Governor-General— Northern Territory—Report on Administration for year 1937-38.

  - Mr. Curtin (Leader of the Opposition) moved, as an amendment, That all the words after "That" be omitted with a view to inserting the following words in place thereof:—"this House, being desirous of being completely assured as to the needs and resources of the widow and children of the late Prime Minister (the beneficiaries of this proposal), refuses to accord a second reading to a Bill proposing a grant of such magnitude until the needs and resources of the said beneficiaries as well as the amount of the grant (if any) which may be properly made by this House have been examined and reported on by a Committee representing all parties in this House".

Debate continued.

Mr. James moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Question—put and passed.—Bill read a first time.

Mr. John Lawson moved, That the Bill be now read a second time. Question—put and passed.—Bill read a second time.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Prowse reported accordingly.

On the motion of Mr. John Lawson, the House adopted the Report, and the Bill was read a third time.
