TINNED PLATE INDUSTRY-MINISTERIAL STATEMENT.-Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement informing the House of the decision of the Government to refer to the Tariff Board for inquiry and report proposals submitted for the establishment in Australia of the Tinned Plate Industry.
- 3. MANUFACTURE IN AUSTRALIA OF ENGINES AND CHASSIS OF MOTOR VEHICLES-MINISTERIAL STATEMENT. -Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement announcing the decision of the Government to facilitate the manufacture in Australia, under certain conditions, of Engines and Chassis of Motor Vehicles.
