- 2. WAR WITH GERMANY-MINISTERIAL STATEMENT.-Mr. McEwen (Minister for External Affairs), by leave, made a Ministerial Statement with reference to recent developments in the war with Germany.
- 3. Adjournment-Motion for Purpose of Discussion.—Mr. Hutchinson rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The necessity, in view of the grave overseas developments, of the formation of a National Government in Australia, representative of all parties'

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly

Mr. Hutchinson moved, That the House do now adjourn.

Mr. Hutchinson not having concluded his speech at the termination of the time allowed by Standing Order No. 257B-

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Prowse reported accordingly.
On the motion of Mr. Fadden (Minister assisting the Treasurer), the House adopted the Report, and, by leave, the Bill was read a third time.

- 13. Postponement of Orders of the Day.—Ordered—That Orders of the Day Nos. 4 and 5 be postponed until after Order of the Day No. 6, Government Business.
- 14. COMMONWEALTH ELECTORAL BILL 1939.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-
 - Debate resumed by Mr. Lazzarini who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the Bill be withdrawn pending the calling of a conference between the governments of the Commonwealth and the States with a view to ensuring a uniform practice in respect to enrolment and voting for Commonwealth and State elections".

Debate continued.

Mr. Curtin (Leader of the Opposition) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

- Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.
- 15. ADJOURNMENT.-Mr. Street (Minister for the Army) moved, That the House do now adjourn. Question—put and passed.
- And then the House, at twenty-three minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
