- 3. MEMBER SWORN.--Thomas William Marwick, Esquire, was introduced, and made and subscribed the Oath required by law.
- 4. DEATH OF MR. D. S. JACKSON.-Mr. Fadden (Acting Prime Minister) referred to the death, on the 28th February last, of Mr. D. S. Jackson, and moved, That this House expresses its deep regret at the death of Mr. David Sydney Jackson, a former Member for the Division of Bass, places on record its appreciation of his meritorious public service, and tenders its heartfelt sympathy to his widow in her bereavement.
 - And Mr. Curtin (Leader of the Opposition) having seconded the motion, and other honorable Members having addressed the House in support thereof, and all Members present having risen, in silence-Question-passed.

On such Thursday General Business shall have precedence of Government Business until nine o'clock p.m. Question-put and passed.
- 11. ADJOURNMENT.-Mr. Fadden (Acting Prime Minister) moved, That the House do now adjourn. Debate ensued.

Question—put and passed.

- And then the House, at ten minutes to six o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
