- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
- 2. PARACHUTES FOR R.A.A.F.—MINISTERIAL STATEMENT.—Mr. McEwen (Minister for Air), by leave, made a Ministerial Statement with reference to the availability of parachutes for the Royal Australian Air Force, following the death of Aircraftman E. A. Girdler owing to a parachute allegedly not being available.
- 3. STORAGE OF EMERGENCY SUPPLIES-MINISTERIAL STATEMENT.—Sir Earle Page (Minister for Commerce), by leave, made a Ministerial Statement informing the House of the action being taken to secure a sufficient supply in all parts of Australia of certain essential commodities in the event of any war emergency dislocating normal means of transport.
- 4. WOMEN'S AUXILIARY AUSTRALIAN AIR FORCE—MINISTERIAL STATEMENT.—Mr. McEwen (Minister for Air), by leave, made a Ministerial Statement informing the House that a Women's Auxiliary to the Royal Australian Air Force was being formed on the same lines as the organization incorporated in the Royal Air Force.

Mr. Makin, by leave, also made a Statement with reference to the matter.

- 5. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Holloway rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The necessity for improving the wage standards of employees with particular reference to the basic wage and allowances related thereto". Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise
