1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.

2. Message from the Governor-General.—Assent to Bill.—The following Message from His Excellency the Governor-General was received, and was read by Mr. Speaker :-

A Proposed Law intituled "Judiciary (Diplomatic Representation) Act 1942" as finally passed by the Senate and the House of Representatives of the Commonwealth, having been presented to the Governor-General for the Royal Assent, His Excellency has, in the name and on behalf of His Majesty, assented to the said Law.

3. MESSAGE FROM THE SENATE. -- AUSTRALIAN BROADCASTING BILL 1942.--- Mr. Speaker announced the receipt of the following Message from the Senate :---

MR. SPEAKER.

Message No. 108. The Senate has passed a Bill for "An Act relating to Broadcasting", and transmits the same to the House of Representatives for its concurrence.

Mr. Beasley (Minister for Supply and Development) moved, That the Bill transmitted by the foregoing Message be now read a first time.

Question—put and passed.—Bill read a first time. Ordered—That the second reading be made an Order of the Day for the next sitting.

4. COAL-MINING INDUSTRY-MINISTERIAL STATEMENT.-Mr. Curtin (Prime Minister), by leave, made a Ministerial Statement informing the House of the position relating to stoppages of work in the coal-mining industry, their effect on output, and the action taken by the Government to achieve continuous production.

Mr. James asked leave to make a Statement in connexion with the matter.

Objection being raised, leave not granted.

- 5. WAR EXPENDITURE-JOINT COMMITTEE-FOURTH PROGRESS REPORT.- Mr. Johnson, Deputy Chairman, brought up the Fourth Progress Report from the Joint Committee on War Expenditure.
- 6. DEPARTMENT OF AIR-OVERTIME-MINISTERIAL STATEMENT.-Mr. Drakeford (Minister for Air), by leave, made a Ministerial Statement with reference to payments for overtime to certain officers in the Air Force Finance Office, Melbourne.
- 7. PRISONERS OF WAR IN AUSTRALIA-MINISTERIAL STATEMENT.-Mr. Forde (Minister for the Army), by leave, made a Ministerial Statement regarding the employment of prisoners of war in Australia.
- 8. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.-Mr. Fadden (Leader of the Opposition) rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The failure of the Government to protect the interests of the public and of the trading community by prematurely disclosing Government policy concerning the rationing of clothing and the adverse effect such disclosure has had upon war-time finance".

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly---Mr. Fadden moved, That the House do now adjourn.

Ordered-That Mr. Fadden be granted an extension of time.

Debate ensued.

Ordered- That Mr. Dedman (Minister for War Organization of Industry) be granted an extension of time.

Debate continued.

The debate having been continued for two hours, it was terminated in accordance with Standing Order No. 257B.

Motions agreed to.

Resolutions to be reported, and leave asked to sit again.

The House resumed ; Mr. Guy reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

Mr. Chifley moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question-put and passed.

The Resolutions reported from the Committee were read, and, on the motion of Mr. Chifley, were adopted by the House.

Ordered—That Mr. Chifley and Mr. Frost do prepare and bring in Bills to carry out the foregoing Resolutions.

- 20. Question—put and passed.
