- 1. The House met, at half-past nine o'clock a.m., pursuant to adjournment.—Mr. Speaker (the Honorable W. M. Nairn) took the Chair, and read Prayers.
- 2. Papers.—The following Paper was presented, by command of His Excellency the Governor-General—Australian Wool Board—Sixth Annual Report, for year 1941-42.

Ordered to lie on the Table.

The following Paper was presented, pursuant to Statute—Superphosphate Bounty Act—Return for year 1941-42.

- 3. Dairying Industry Assistance Bill 1942.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—Debate resumed.
 - Mr. Hutchinson moved, as an amendment, That all words after "Bill" be omitted with a view to inserting the following words in place thereof:—" be withdrawn and redrafted so as to provide a more equitable scheme, and, in particular, one which will reasonably relate the price received by the primary producer and his costs of production".

Debate continued.

Amendment negatived.

Question—That the Bill be now read a second time—put and passed.—Bill read a second time. Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

Bill, by leave, taken as a whole, and agreed to.
