1. The House met, at three o'clock p.m., pursuant to adjournment.

2. MESSAGE FROM THE GOVERNOR-GENERAL.-RESIGNATION OF SPEAKER.-The following Message from His Excellency the Governor-General was received, and was read at the Table by the Clerk :-

Message No. 108.

Governor-General.

GOWRIE,

I desire to acquaint the House of Representatives of the Commonwealth that I have received a letter dated 21st June, 1943, from the Honorable Walter Maxwell Nairn, M.P., tendering his resignation as Speaker of the House of Representatives, which resignation I have accepted. Accordingly, I invite the House, at its next Sitting, to proceed to elect a new Speaker.

- 3. ELECTION OF SPEAKER.-Mr. Conelan, addressing himself to the Clerk, proposed to the House for its Speaker Mr. John Solomon Rosevear, and moved, That he do take the Chair of this House as Speaker, which motion was seconded by Mr. Mulcahy.
 - Mr. Rosevear informed the House that he accepted nomination.
 - Sir Charles Marr, addressing himself in like manner to the Clerk, proposed to the House for its Speaker Mr. Rowland James, and moved, That he do take the Chair of this House as Speaker.
 - Mr. James declined nomination.
 - There being no further proposal, Mr. Rosevear was declared elected as Speaker, and Mr. Conelan and Mr. Mulcahy conducted him to the Chair.
 - Mr. Rosevear returned his acknowledgments to the House for the honour it had been pleased to confer upon him by choosing him to be its Speaker, and thereupon sat down in the Chair.
 - Then the Mace, which before lay under the Table, was laid upon the Table. Mr. Curtin (Prime Minister), Mr. Fadden (Leader of the Opposition), Mr. Brennan, Mr. Nairn and Mr. Cameron congratulated Mr. Speaker, who expressed his thanks.
- 4. PRESENTATION OF THE SPEAKER.—Mr. Curtin (Prime Minister) stated that he had ascertained that it would be the pleasure of His Excellency the Governor-General to receive the Speaker in the Prime Minister's room at Parliament House immediately.

And the sitting of the House having been suspended— Mr. Speaker went with Mr. Conelan and Mr. Mulcahy and other honorable Members to attend His Excellency.

- Upon resuming the Chair, Mr. Speaker reported that he had presented himself to His Excellency the Governor-General as the choice of the House of Representatives, and that His Excellency had been kind enough to congratulate him upon his election.
- 5. RESIGNATION OF CHAIRMAN OF COMMITTEES.—The following letter from the Chairman of Committees (Mr. Prowse) was read by Mr. Speaker :---
