- 5. LAY-BY SALES—APPLICATION OF RATIONING—STATEMENT BY MEMBER.—Mr. Coles, by leave, made a Statement informing the House of the principles observed by the Rationing Commission in applying coupon rationing to lay-by sales.

Mr. Beasley moved, by leave, That the second reading be made an Order of the Day for a later hour this day.

Question—put and passed.

7. WAR SERVICE ESTATES BILL 1943.—Mr. Beasley (Acting Attorney-General) moved, by leave, That he have leave to bring in a Bill for an Act to amend the War Service Estates Act 1942. Question—put and passed.

Mr. Beasley then brought up the Bill accordingly, and moved, That it be now read a first time.
