## WEDNESDAY, 13TH OCTOBER, 1943.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. CLOTHING FACTORIES IN COUNTRY AREAS—MINISTERIAL STATEMENT.—Mr. Beasley (Minister for Supply and Shipping), by leave, made a Ministerial Statement with regard to the establishment, by private enterprise, of clothing factories in country areas.
- 3. Public Works Committee—Reference of Work—Erection of Arbitration Court Building, MELBOURNE.—Mr. Lazzarini (Minister representing the Minister for the Interior) moved, by leave, That, in accordance with the provisions of the Commonwealth Public Works Committee Act 1913-1936, the following proposed work be referred to the Parliamentary Standing Committee on Public Works for investigation and report:—Erection of Arbitration Court Building, Melbourne.

Mr. Lazzarini having laid on the Table plans in connexion with the proposed work-

Debate ensued.

Question—put and passed.

4. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Anthony rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The inevitable serious decline in the production of vital foodstuffs and other commodities essential to the needs of our military forces, our civilian population, our Allies in this country, and Great Britain, consequent upon the depletion of labour in our rural industries and elsewhere; the failure of the Government to provide farm machinery, engines, milking machines and other labour saving plant and equipment to enable farmers to increase production; and the necessity for urgent action to increase supplies of foodstuffs, particularly meat, butter, fruit and vegetables."

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. Anthony moved, That the House do now adjourn.

Ordered—That Mr. Anthony be granted an extension of time.

Debate ensued.

Member named and suspended.--Mr. Speaker named the honorable Member for Barker (Mr. Cameron) for reflecting on the Chair.

Mr. Forde (Minister for the Army) moved, That the honorable Member for Barker be suspended from the service of the House.

Question—put and passed.

The honorable Member was, therefore, under Standing Order No. 59, suspended for the remainder of the day's sitting, and he accordingly withdrew from the Chamber. Debate continued.

Ordered—That Mr. Scully (Minister for Commerce and Agriculture) be granted an extension of time. Debate continued.

Ordered—That Mr. Forde be granted an extension of time. Ordered—That Sir Earle Page be granted an extension of time.

Ordered-That Mr. Dedman (Minister for War Organization of Industry) be granted an extension of time.

The debate having been continued for two hours, it was terminated in accordance with Standing Order No. 257B.

Mr. Holt asked leave to move, That so much of the Standing Orders be suspended as would prevent the time for the debate being extended.

Objection being raised, leave not granted.
