- The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. Death of Major-General G. A. Vasey and Major-General R. M. Downes-Ministerial STATEMENT.—Mr. Curtin (Prime Minister), by leave, announced with deep regret the death of Major-General G. A. Vasey, and Major-General R. M. Downes, and other Service personnel in an aircraft accident. Mr. Curtin paid a tribute to the gallant and distinguished service of Major-General Vasey and Major-General Downes and expressed sympathy with the relatives of those who lost
 - Mr. Menzies (Leader of the Opposition) and Mr. Fadden supported the remarks of the Prime Minister and joined in the expression of sympathy.
- 3. Absence of Mr. Makin-Performance of Ministerial Duties.-Mr. Curtin (Prime Minister) informed the House that during the absence, owing to an accident, of Mr. Makin, Senator Cameron would act as Minister for the Navy, Minister for Munitions, and Minister for Aircraft Production, and that Mr. Beasley (Vice-President of the Executive Council) would represent those Departments in the House of Representatives.
- 4. CASE OF MRS. M. E. PEDVIN-MINISTERIAL STATEMENT. -- Mr. Curtin (Prime Minister), by leave, made a Ministerial Statement announcing that the members of the Committee to inquire into the circumstances surrounding the issue of a notice to quit premises to Mrs. M. E. Pedvin, of Griffith, Australian Capital Territory, would be Mr. Beasley (Vice-President of the Executive Council), Senator Finlay, Mr. Abbott, Mr. Pollard and Mr. White.
