- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. Death of the Honorable Sir Arthur Robinson.—Mr. Chifley (Acting Prime Minister) informed the House of the death on the 17th May of the Honorable Sir Arthur Robinson, and moved, That this House expresses its sincere regret at the death of the Honorable Sir Arthur Robinson, K.C.M.G., a former Member of the House of Representatives for the Division of Wannon, a Member of both Houses of the Parliament of Victoria and a Minister of the Crown, places on record its appreciation of his meritorious public service and tenders its deep sympathy to his widow and the members of his family in their bereavement.

And Mr. Menzies (Leader of the Opposition) having seconded the motion, and Mr. Fadden having addressed the House in support thereof, and all Members present having risen, in silence-

- 7. WAR GRATUITY BILL 1945.—Mr. Chifley (Treasurer) moved, pursuant to notice, That he have leave to bring in a Bill for an Act relating to the payment of War Gratuity to members of the Defence Force in respect of War Service.

 Question—put and passed.
- 8. Re-establishment and Employment Bill 1945.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time—And on the Amendment moved thereto by Mr. Fadden, viz.:—That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the Bill be withdrawn and re-drafted to provide more adequately for the re-establishment of members of the forces, more especially with regard to the incorporation of (a) effective preference unlimited as to time, and (b) the maintenance of the principle of preference in the Commonwealth Public Service Acts"—

Question—That the words proposed to be omitted stand part of the question—put.

Official War Photograph—Ministerial Statement.—Mr. Chifley (Acting Prime Minister), by leave, made a Ministerial Statement informing the House of the terms of a report made by the Right Honorable Member for Yarra (Mr. Scullin) and the Right Honorable Member for Cowper (Sir Earle Page) upon the matter of whether there was any unworthy motive on the part of the photographer from the Department of Information and the war correspondent in regard to an official photograph purporting to be a picture of an Australian soldier in action in the Aitape sector, New Guinea.
- Re-establishment and Employment Bill 1945.—The Order of the Day having been read for the
 resumption of the debate on the question, That the Bill be now read a second time—
 Debate resumed.

Question—put and passed.—Bill read a second time.

13. Adjournment.—Mr. Chifley (Acting Prime Minister) moved, That the House do now adjourn. Question—put and passed.

And then the House, at three minutes past ten o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
