- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. ALTERATION OF HOUR OF NEXT MEETING.—Mr. Chifley (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at half-past ten o'clock a.m. Debate ensued. Question—put and passed.
- 3. PEA SEED-MINISTERIAL STATEMENT.-Mr. Dedman (Minister for Post-war Reconstruction), by leave, made a Ministerial Statement with reference to the pea seed position in Australia.
- 4. Papers.—The following Papers were presented, pursuant to Statute—

- 6. Darwin Lands Acquisition Bill 1945.—The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time— Debate resumed.

Ordered—That Mr. Cameron be granted an extension of time.

Mr. Cameron moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof:—"the second reading of the Bill be deferred until the Minister for the Interior and the Minister for Post-war Reconstruction have accepted the invitation of the Northern Territory Development League to visit Darwin and hear the views of residents of the Northern Territory on this Bill ".

7. Message from the Governor-General.—Darwin Lands Acquisition Bill 1945.—The following Message from His Royal Highness the Governor-General was presented, and was read by Mr. Speaker:—

HENRY,

Governor-General.

Message No. 17.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the acquisition by the Commonwealth, for certain purposes, of land in the Northern Territory of Australia comprised in the Town of Darwin and its environs, and for other purposes.

Canberra, 18th July, 1945.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Johnson (Minister for the Interior) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to authorize the acquisition by the Commonwealth, for certain purposes, of land in the Northern Territory of Australia comprised in the Town of Darwin and its environs, and for other purposes.

Debate ensued.

Question—put and passed.

Resolution to be reported.

The House resumed; Mr. Riordan reported accordingly.

The said Resolution was read, and, on the motion of Mr. Johnson, by leave, was adopted by the House.

8. Darwin Lands Acquisition Bill 1945.—The Order of the Day having been read for the further consideration of this Bill in Committee of the whole House—

Mr. Speaker left the Chair, and the House again resolved itself into a Committee of the Whole.

Mr. Francis moved, That the clause be postponed.

Question—put and negatived.

Mr. Cameron moved, as an amendment, That the following proviso be added to the clause:

"Provided that, in the event of the Commonwealth and the freeholder being unable to agree upon compensation, there shall be an appeal to a committee competent to make a valuation of Darwin lands.".

Debate ensued.

Amendment negatived.

Debate continued.

Clause agreed to.

Clauses 5 and 6 agreed to.

Schedule agreed to.
Title agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Riordan reported accordingly.

On the motion of Mr. Johnson (Minister for the Interior), the House adopted the Report, and, by leave, the Bill was read a third time.

9. Message from the Senate.—Banking Bill 1945.—Mr. Speaker announced the receipt of the following Message from the Senate:--
