- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. NOTIFICATION OF RETURN TO WRIT (FREMANTLE DIVISION).-Mr. Speaker announced that he had received a notification from the Chief Electoral Officer for the Commonwealth in connexion with the Writ which he had issued on the 18th July last for the election of a Member to serve for the Electoral Division of Fremantle, in the State of Western Australia, to fill the vacancy caused by the death of the Right Honorable John Curtin, and that, by the notification, it appeared that Kim Edward Beazley had been elected in pursuance of the said Writ.
- 3. Member Sworn.--Kim Edward Beazley, Esquire, was introduced, and made and subscribed the Oath required by law.
- 4. THE WAR-SURBENDER OF JAPAN-MINISTERIAL STATEMENT.-Mr. Chifley (Prime Minister), by leave, made a Ministerial Statement informing the House formally of the cessation of hostilities with Japan.
- 5. The War-Cessation of Hostilities-Message from and Address to the King.-Mr. Chifley (Prime Minister) read to the House the following Message received from His Majesty the King on the occasion of the cessation of hostilities in the Pacific :-
 - "The surrender of Japan has brought to a victorious end the war which has engaged our full fighting strength all over the world. I send my heartfelt congratulations to the men and women of my navies, armies and air forces throughout the British Commonwealth and Empire. Through the long years of the grim struggle with our enemies in the West and in the East your unflinching resolution and indomitable courage in the face of manifold adversity have earned you the eternal gratitude of your countrymen. Many of your comrades have fallen in the fight. With you I grieve for their loss, for the sufferings of the wounded and for the sorrows of the bereaved. With you I look forward to the safe homecoming of those who have had to endure captivity. By God's mercy the forces of evil have been overthrown. But many tasks remain to be accomplished if the full blessings of peace are to be restored to a suffering world. It is the duty of each one of us to ensure that your comrades have not died in vain and that your own hard won achievements are not lost to the cause of freedom in which you undertook them. On behalf of all my peoples I thank you. God bless you all.

Mr. Chifley then moved, That the following Address be forwarded to His Majesty:-

TO THE KING'S MOST EXCELLENT MAJESTY:

Most Gracious Sovereign:

We, Your Majesty's dutiful and loyal subjects, the Members of the House of Representatives of the Commorwealth of Australia, in Parliament assembled, desire to express to Your Majesty our heartfelt congratulations on the victorious conclusion to the World War.

We rejoice with Your Majesty in the deliverance brought to all the enslaved peoples by the

triumph of Your Majesty's forces in conjunction with those of Your Majesty's Allies.

We desire to express the feeling which exists among Your Majesty's Australian subjects that Your Majesty and Your Gracious Consort have by unfailing courage and constancy set an inspiring example during our darkest days, and that your personal exertions, your determination to share the trials of your subjects, and your unfailing sympathy with them in the ordeal they have endured, have contributed to the high national morale which helped to ensure victory.

We devoutly trust that Your Majesty's reign, so many years of which have been darkened

by war, may long continue in a world at peace.

Mr. Menzies (Leader of the Opposition) having seconded the motion, and Mr. Fadden having addressed the House in support thereof-Question—put and passed.

6. THE WAR--VOTE OF THANKS TO THE FIGHTING SERVICES AND OTHERS.--Mr. Chifley (Prime Minister) moved, by leave-

That the thanks of this House be accorded to the officers, warrant officers, petty officers and men of the Royal Australian Navy, for their heroic services in every theatre of war, for the guardianship of Australia from the attacks of our enemies, for the increasing vigilance in the patrol of many seas, for their courage and skill in convoying their soldier comrades and supplies to operational areas, and for the prestige they have won for their country wherever they have been.

That the thanks of the House be accorded to the officers, warrant officers, non-commissioned officers and men of the Australian Military Forces in the field for their courage and efficiency, their endurance in circumstances of unexampled hardship, for their magnificent achievements and for their undaunted spirit which has carried them through years of toil and suffering to complete

That the thanks of this House be accorded to the officers, non-commissioned officers and men of the Royal Australian Air Force for their brilliant daring and conspicuous skill over land and sea, and for their calm courage and devotion to whatever dangerous and vital duties they have been allotted.

That the thanks of this House be offered to the men of the Merchant Navy, who carried out the vital task of keeping open the supply lines, always at great risk and imposing severe tests upon their endurance.

That the thanks of this House be accorded to the women of all the auxiliary services of the three arms of the fighting forces for their devotion and skill and solicitude for the sick and wounded of our sailors, soldiers and airmen.

That this House records its deep appreciation of the devotion and sacrifice of the fathers, mothers, wives and sisters of Australia's sailors, soldiers and airmen.

That this House records its deep appreciation of the efforts, money and gifts from the women, men and children of Australia to mitigate the hardships of Australian fighting men, to alleviate the lot of our prisoners of war and to make more comfortable the sick and wounded.

That the thanks of this House be offered to munitions and war workers generally in secondary and primary industries; to those men of 1914-18 who gave valuable home service in garrison and other work, and to the Volunteer Defence Corps.

That this House acknowledges with deep submission and reverence the heroism of those who have fallen in the service of their country, and tenders its sympathy to their relatives in the hour of their sorrow and their pride.

Mr. Menzies (Leader of the Opposition) having seconded the motion, and Mr. Fadden having addressed the House in support thereof-

Question---put and passed.

Resolved--That Mr. Speaker forward copies of the foregoing Resolution to the various Ministers of State for communication to the personnel referred to therein.

- 7. THE WAR-CONGRATULATIONS TO GENERAL MACARTHUR.-Mr. Chifley (Prime Minister) moved, by leave, That this House offers to the Supreme Commander in the Pacific (General Douglas MacArthur) its warmest congratulations on the success achieved by the Australian and Allied forces under his command, and recalls with deep gratitude his outstanding contribution to the victory in the Pacific and to the defence of Australia during the most critical period of our history.
 - Mr. Menzies (Leader of the Opposition) having seconded the motion, and Mr. Fadden having addressed the House in support thereof-Question-put and passed.
- 8. THE WAR—SURRENDER OF JAPAN—MINISTERIAL STATEMENT—MOTION FOR PRINTING PAPER.— Mr. Chifley (Prime Minister), by leave, made a Ministerial Statement with reference to Australia's participation in the surrender of Japan and in matters arising therefrom, and, by command of His Royal Highness the Governor-General, laid upon the Table the following Paper-

The War—Surrender of Japan—Ministerial Statement and moved, That the Paper be printed.

Mr. Menzies (Leader of the Opposition) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered--That the resumption of the debate be made an Order of the Day for the next sitting.

- 9. Tributes to Leaders of United Nations-Ministerial Statement.-Mr. Chifley (Prime Minister), by leave, referred to the devoted services of the Leaders of the United Nations during the war period. Mr. Menzics (Leader of the Opposition) and Mr. Fadden, by leave, also addressed the House.
- 10. Council of Foreign Ministers—Australian Representation—Ministerial Statement.—Mr. Chifley (Prime Minister), by leave, informed the House that Mr. Evatt (Minister for External Affairs) would attend, on behalf of Australia, the meeting of the Council of Foreign Ministers to be held in London in September next.
- 11. Australian Representation in the United Kingdom-Ministerial Statement.-Mr. Chifley (Prime Minister), by leave, informed the House that, upon the expiration of the extended term for which the Right Honorable S. M. Bruce, C.H., M.C., was appointed as High Commissioner of the Commonwealth in the United Kingdom, Mr. Evatt (Minister for External Affairs) will perform the duties of the office during his stay in London. Afterwards, Mr. Beasley (Minister for Defence) will proceed to London as Resident Minister for Australia for a short period.

12. Demobilization of Defence Forces-Ministerial Statement-Motion for Printing Paper. Mr. Dedman (Minister for Post-war Reconstruction), by leave, made a Ministerial Statement with reference to the plans for the demobilization of the Defence Forces, and, by command of His Royal Highness the Governor-General, laid upon the Table the following Paper-

and moved, That the Paper be printed.

Mr. Harrison moved, That the debate be now adjourned.
