## WEDNESDAY, 10TH JULY, 1946.

- 1. The House met, at three o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. MINISTERIAL STATEMENT—LEAVE TO MAKE NOT GRANTED.—Mr. Drakeford (Minister for Air) asked leave to make a Ministerial Statement with reference to certain newspaper articles concerning the Royal Australian Air Force.

  Objection being raised, leave not granted.
- 3. Suspension of Standing Orders.—Mr. Chifley (Prime Minister) moved, That so much of the Standing Orders be suspended as would prevent Mr. Drakeford (Minister for Air) from making a Ministerial Statement in regard to articles appearing in certain newspapers with reference to the Royal Australian Air Force.

Debate ensued.

Question-put and passed, with the concurrence of an absolute majority of the Members of the House.

4. ROYAL AUSTRALIAN AIR FORCE—NEWSPAPER ARTICLES ALLEGING MALADMINISTRATION AND UNSOUND ORGANIZATION—MINISTERIAL STATEMENT—MOTION FOR PRINTING PAPER.—Mr. Drakeford (Minister for Air) made a Ministerial Statement with reference to allegations contained in newspaper articles written by Air Vice-Marshal W. D. Bostock, of maladministration and unsound organization of the Royal Australian Air Force during the war. Mr. Drakeford then, by command of His Royal Highness the Governor-General, laid upon the Table the following Paper:—
