3. MEAT AND DAIRY PRODUCE AGREEMENTS WITH THE UNITED KINGDOM—MINISTERIAL STATEMENT—MOTION FOR PRINTING PAPER.—Mr. Pollard (Minister for Commerce and Agriculture), by leave, made a Ministerial Statement with reference to the long-term purchase agreements for meat and dairy produce entered into between the Government of the United Kingdom and the Commonwealth Government. Mr. Pollard then, by command of His Royal Highness the Governor-General, laid upon the Table the following Paper:—
