- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. PROPOSED ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Harrison proposing to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely:—" The need for a full public inquiry into the administration of the Division of Import Procurement relative to matters associated with and arising out of the Goldberg case " Speaker's Ruling .- Mr. Speaker ruled that such a motion would not be in order as it involved reference to a matter which is sub judice.

Dissent from Speaker's Ruling .- Mr. Menzies (Leader of the Opposition) handed in, in writing, the following objection to the Ruling:-That Mr. Speaker's Ruling, that the motion by the honorable Member for Wentworth is out of order, be disagreed with.

The debate thereon was forthwith adjourned to the next day of sitting.
