- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment .-- Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. PAPERS.—The following Paper was presented, by command of His Excellency the Governor-General— International Trade Negotiations -- Tariff Requests and Preferences--Schedules showing additional items in the Australian Tariff the subject of current international trade negotiations.

- 3. INCOME TAX ASSESSMENT BILL 1947.- The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time---
  - Debate resumed by Mr. Fadden who moved, as an amendment, That all words after "That" be omitted with a view to inserting the following words in place thereof :---"the Bill be withdrawn and redrafted for the purpose of adjusting the glaring anomalies against the family man which are contained in it, and for the purpose of substituting a straight deduction system in lieu of the present cumbersome and unfair rebate system ". Debate continued.

Mr. Anthony moved, That the debate be now adjourned. Question-That the debate be now adjourned- put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.
