- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment. Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. MINISTERIAL STATEMENT—LEAVE TO MAKE NOT GRANTED.—Mr. Pollard (Minister for Commerce and Agriculture) asked leave to make a Ministerial Statement.

 Objection being raised, leave not granted.
- 3. Adjournment-Motion for Purpose of Discussion.—Mr. Lang rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The necessity for the transfer of the short-wave service known as 'Radio Australia' from the Department of Information to the control of the Australian Broadcasting Commission".

Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly—

Mr. Lang moved, That the House do now adjourn.

Debate ensued.

5. Message from the Governor-General.—Parliamentary Allowances Bill 1947.—The following Message from His Excellency the Governor-General was presented, and was read by Mr. Speaker:—

Governor-General.

Message No. 29.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the Parliamentary Allowances Act 1920–1938, and for other purposes.

Canberra, 27th May, 1947.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Chifley (Prime Minister) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the *Parliamentary Allowances Act* 1920-1938, and for other purposes.

Question—put and passed.

Resolution to be reported.

The House resumed; Mr. Clark reported accordingly.

Mr. Chifley moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question—put and passed.

The Resolution reported from the Committee was read, and, on the motion of Mr. Chifley, was adopted by the House.

Ordered - That Mr. Chifley and Mr. Riordan do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Chiffey then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed. -Bill read a first time.

Mr. Chifley moved, That the Bill be now read a second time.

Mr. Menzies (Leader of the Opposition) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered —That the resumption of the debate be made an Order of the Day for the next sitting.

6. Interim Forces Benefits Bill 1947.—Mr. Dedman (Minister for Defence) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to provide certain Benefits for members of the Interim Forces by reason of their service with such Forces, and for other purposes.

Question —put and passed.

Mr. Dedman then brought up the Bill accordingly, and moved, That it be now read a first time.

Question -- put and passed. -Bill read a first time.

Mr. Dedman moved, by leave, That the second reading be made an Order of the Day for a later hour this day.

Question- put and passed.

- 7. APPROVED DEFENCE PROJECTS PROTECTION BILL 1947.—Mr. Dedman (Minister for Defence) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to provide for the protection of Approved Defence Projects, and for other purposes.

 Question—put and passed.
- 8. British Commonwealth Pacific Airlines Agreement Bill 1947.—Mr. Dedman (Minister for Defence), for Mr. Barnard (Acting Minister for Civil Aviation), moved, pursuant to notice, That he have leave to bring in a Bill for an Act to authorize the Execution, by or on behalf of the Commonwealth, of an Agreement for the Purpose of Establishing, Operating and Developing Trans-Pacific Air Services between Australia and North America and between New Zealand and North America, and for other purposes.

Question—put and passed.

Mr. Dedman then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

On the motion of Mr. Holloway (Minister representing the Minister for Social Services), the House adopted the Report, and, by leave, the Bill was read a third time, after debate.

Mr. Harrison moved, That the debate be now adjourned.

 Supply Bill (No. 1) 1947-48. The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Mr. Fraser moved, That the debate be now adjourned.

Question—That the debate be now adjourned - put and passed.

Ordered That the resumption of the debate be made an Order of the Day for the next sitting.
