- 2. Petitions.—Mr. Howse presented a Petition from certain electors of the Division of Calare, praying that no further steps should be taken by the Government towards the nationalization of the banking system without first seeking the authority of the Australian people.

 Mr. Cameron presented a Petition from certain electors of the Division of Barker, praying that the

House will maintain the present banking system unimpaired.

Petitions severally received and read.

- 3. MINISTERIAL ARRANGEMENTS.—Mr. Chifley (Prime Minister) informed the House that, during the absence abroad of Mr. Evatt, Senator McKenna would act as Attorney-General and he would act as Minister for External Affairs. Mr. Holloway would represent the Acting Attorney-General in the House of Representatives.
- 4. ALTERATION OF DAY OF NEXT MEETING.—Mr. Chifley (Prime Minister) moved, That the House, at its rising, adjourn until Wednesday next at three o'clock p.m.

Mr. Chifley moved, That the Bill be now read a second time.

Mr. Menzies (Leader of the Opposition) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

Question—put and passed.

Mr. Chifley then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Chifley moved, by leave, That the Bill be now read a second time.

Mr. Holt moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered -That the resumption of the debate be made an Order of the Day for the next sitting.
