- 1. The House met, at three o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. DISTINGUISHED VISITOR.—Mr. Speaker informed the House that the Honorable Robert Semple, Minister of Works and of Railways and Minister in charge of State Hydro-Electric Department, Roads and Public Buildings in the Government of the Dominion of New Zealand, was within the precincts. The distinguished visitor thereupon, with the concurrence of honorable Members, was provided with a seat on the floor of the House.
- 3. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Lang rose in his place, and said that he proposed to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The report of the Auditor-General for 1946-47, with particular reference to-
 - (a) The request that the Auditor-General be given access to assessment it is in the Taxation Department;
 - (b) The disclosure that £50,000,000 in assessed income tax had not been collected at the 30th June, last;
 - (c) The practice of diverting money from Consolidated Revenue to Reserve Funds, which are in excess of anticipated requirements;
 - (d) The disregard of economy in public spending;

 - (e) Misuse of official cars;
 (f) Losses on Government contracts and market pools; and
 - (g) Financing of Glen-Davis National Oil Pty. Ltd.".
 - Mr. Speaker thereupon called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly-
 - Mr. Lang moved, That the House do now adjourn.

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Clark reported accordingly.

On the motion of Mr. Pollard, the House adopted the Report, and the Bill was read a third time.

15. ADJOURNMENT.—Mr. Dedman (Minister for Defence) moved, That the House do now adjourn. Debate ensued.

Question—put and passed.

And then the House, at sixteen minutes to eleven o'clock p.m., adjourned until to-morrow at half-past two o'clock p.m.
