- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker (the Honorable J. S. Rosevear) took the Chair, and read Prayers.
- 2. PAPERS.—The following Papers were presented, pursuant to Statute-
 - Canned Fruits Export Control Act-Twenty-second Annual Report of the Australian Canned Fruits Board, for year 1947-48, together with Statement by Minister regarding the operation of the Act.
 - Dairy Produce Export Control Act-Twenty-third Annual Report of the Australian Dairy Produce Board, for year 1947-48, together with Statement by Minister regarding the operation of the Act.
 - Dried Fruits Export Control Act-Twenty-fourth Annual Report of the Dried Fruits Control Board, for year 1947-48, together with Statement by Minister regarding the operation of the Act.
- 3. COMMONWEALTH CONCILIATION AND ARBITRATION BILL 1948.—The Order of the Day having been read for the second reading—Mr. Holloway (Minister representing the Acting Attorney-General) moved, That the Bill be now read a second time.
 - Mr. Holt moved, That the debate be now adjourned.
