1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-The Deputy Speaker (Mr. Clark) took the Chair, and read Prayers.

2. MESSAGE FROM THE GOVERNOR-GENERAL .-- STATES GRANTS BILL 1949.-- The following Message from His Excellency the Governor-General was presented, and was read by Mr. Deputy Speaker :-

W. J. McKELL,

Governor-General.

Message No. 41.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purpose of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund sums for the purposes of Financial Assistance to the States of South Australia and Tasmania.

Canberra, 17th June, 1949.

Ordered-That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Deputy Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

(In the Committee.)

Mr. Chifley (Treasurer) moved, That it is expedient that an appropriation of revenue be made for the purpose of a Bill for an Act to grant and apply out of the Consolidated Revenue Fund sums for the purposes of Financial Assistance to the States of South Australia and Tasmania.

Question-put and passed.

Resolution to be reported.

The House resumed; Mr. Lazzarini reported accordingly.

Mr. Chiffey moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question—put and passed.

Mr. Chifley then brought up the Bill accordingly, and moved, That it be now read a first time. Question—put and passed.—Bill read a first time.

Mr. Chifley moved, That the Bill be now read a second time.

Dame Enid Lyons moved, That the debate be now adjourned.

Question-That the debate be now adjourned-put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

3. INTERNATIONAL WHEAT AGREEMENT BILL 1949.--The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-Debate resumed.

Mr. Hamilton was granted leave to continue his speech when the debate is resumed.

Ordered-That the debate be now adjourned, and that the resumption of the debate be made an Order of the Day for the next sitting.
