- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. Ministerial Changes, Changes in Departments and Administrative Arrangements.-Mr. Menzies (Prime Minister) formally announced to the House details of recent changes in Ministerial portfolios as follows :-The Right Honorable R. G. Casey to be Minister for National Development in addition to his portfolio as Minister for Works and Housing; Senator the Honorable G. McLeay to be Minister for Fuel, Shipping and Transport; and The Honorable Howard Beale to be Minister for Supply. Mr. Menzies also announced that the following departments had been abolished :----Department of Post-war Reconstruction, Department of Information, Department of Supply and Development, Department of Shipping and Fuel, Department of Transport, and three new Departments established, namely-Department of National Development, Department of Fuel, Shipping and Transport, and Department of Supply, and advised the House of the consequent major alterations in the organization of departments. Mr. Menzies informed the House that during the absence of the Minister for Defence (the Honorable Eric J. Harrison), the Minister for the Interior (the Honorable P. A. M. McBride) will administer the Department of Defence. Mr. Menzies also informed the House that, following on the changes mentioned, Ministers in the House of Representatives will be represented in the Senate as follows :-Prime Minister and the Minister for Defence Senator O'Sullivan. Postmaster-General, the Minister for Health, and the Minister Senator Cooper. for Supply Treasurer, the Minister for National Development, the Senator Spooner. Minister for Works and Housing, the Minister for the Army, and the Minister for the Navy Minister for the Interior, the Minister for Air, the Minister for Senator McLeay. Civil Aviation, and the Minister for Commerce and Agriculture Minister for External Affairs, the Minister for External Senator Spicer.
