3. CONFLICT IN KOREA—AUSTRALIA'S SUPPORT OF SECURITY COUNCIL'S RESOLUTIONS.—Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement with reference to the attacks by North Korea against South Korea and informed the House of the action taken by the Government, in response to the call of the Security Council of the United Nations, to place at the disposal of United States of America authorities, on behalf of the Security Council, Australian Naval Forces now in Far-Eastern waters and the Royal Australian Air Force Fighter Squadron stationed in Japan.

Mr. Menzies then moved, by leave, That this House, having before it the Charter of the United Nations and the recent resolutions of the Security Council in relation to Korea, approves of the action taken by the Government in placing at the disposal of the United Nations the Forces

indicated in the Statement of the Prime Minister.

Debate ensued.

Question—put and passed.
