- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.—Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. ALTERATION OF HOUR OF NEXT MEETING.—Mr. Menzies (Prime Minister) moved, That the House, at its rising, adjourn until to-morrow at eleven o'clock a.m. Debate ensued.

Question-put and passed.

- 3. Leave of Absence to Member.—Mr. Evatt moved, That leave of absence for one month be granted to the Right Honorable Member for Melbourne Ports (Mr. Holloway), on the ground of ill-health. Question—put and passed.
- 4. Waterfront Disputes—Sydney and Melbourne—Ministerial Statement.—Mr. Spender (Minister for External Affairs), by leave, made a Ministerial Statement informing the House that work had been resumed on the waterfront in Sydney and Melbourne.
- 5. RATES OF PAY OF FEMALE PUBLIC SERVANTS-MINISTERIAL STATEMENT.-Mr. Anthony (Postmaster-General), by leave, made a Ministerial Statement with reference to the payment of cost of living adjustments and increases granted by arbitration determinations to those female members of the Public Service who now receive the same rates of pay as male members.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act to amend the *Income Tax Assessment Act* 1936–1949, to repeal the *Social Services Contribution Act* 1945–1949 and the *Social Services Contribution Assessment Act* 1945–1948, and for other purposes.

Ordered—That the foregoing Message be taken into consideration, in Committee of the Whole House, forthwith.
