## TUESDAY, 13TH MARCH, 1951.

- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment .-- Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. Promotion of Matters following Professional Advocacy—Statement by Mr. Speaker.— Mr. Speaker made a Statement informing the House that the rule relating to advocacy by honorable Members of matters in which they have been concerned professionally, referred to in May's Parliamentary Practice, 14th ed., page 115, was binding upon all honorable Members except the Attorney-General when he has appeared in court on behalf of the Commonwealth.

Mr. Chifley (Leader of the Opposition), by leave, also made a Statement in connexion with the matter.

- 3. Personal Explanation—Right to Make—Statement by Mr. Speaker.—Mr. Speaker stated that the Chair is the authority to determine whether the indulgence of the House is granted to an honorable Member desiring to explain matters of a personal nature.
- 4. Control of Members outside House—Statement by Mr. Speaker.—Mr. Speaker referred to the action of an honorable Member in making a speech from the steps of Parliament House on Friday last, and informed the House that, as the incident occurred outside the walls of the building, the Chair had no authority to intervene.

Mr. Rosevear asked leave to make a Statement with reference to the matter.

Objection being raised, leave not granted.

COMMUNIST PARTY DISSOLUTION ACT—COURT'S DECISION OF INVALIDITY—MINISTERIAL STATEMENT-MOTION FOR PRINTING PAPER .--- Mr. Menzies (Prime Minister), by leave, made a Ministerial Statement with reference to the decision of the High Court that the Communist Party Dissolution Act was invalid, and informed the House of the effect of the decision in relation to the activities of the Communist Party, the Commonwealth's preparations for war, and the Government's legislative programme. Mr. Menzies then, by command of His Excellency the Governor-General, laid upon the Table the following Paper:—
