- 1. The House met, at half-past two o'clock p.m., pursuant to adjournment.-Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. Petitions.—Petitions, praying that action be taken to secure by a referendum of the people an extension of the Commonwealth's constitutional powers to enable the passing of legislation by the Commonwealth Parliament to control prices, were presented as under :--

- 5. PRECEDENCE TO GOVERNMENT BUSINESS.—Mr. Menzies (Prime Minister), moved, pursuant to notice, That Government Business shall take precedence over General Business to-morrow. Question—put and passed.
- 6. Conciliation and Arbitration Bill (No. 2) 1951.—Mr. Menzies (Prime Minister) moved, pursuant to notice, That he have leave to bring in a Bill for an Act to amend the Conciliation and Arbitration Act 1904-1950, as amended by the Conciliation and Arbitration Act 1951.

Question—put and passed.

Mr. Menzies then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Menzies moved, by leave, That the Bill be now read a second time.

Mr. Evatt moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

7. Message from the Governor-General.—Conciliation and Arbitration Bill (No. 3) 1951.—The following Message from His Excellency the Governor-General was presented, and was read by Mr. Speaker:-

Governor-General.

Message No. 52.

In accordance with the requirements of section fifty-six of the Constitution of the Commonwealth of Australia, the Governor-General recommends to the House of Representatives that an appropriation of revenue be made for the purposes of a Bill for an Act relating to the Tenure of Office of the Chief Conciliation Commissioner.

Canberra, 14th March, 1951.

Ordered—That the foregoing Message be taken into consideration, in Committee of the whole House, forthwith.

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

Mr. Holt (Minister for Labour and National Service) moved, That it is expedient that an appropriation of revenue be made for the purposes of a Bill for an Act relating to the Tenure of Office of the Chief • Conciliation Commissioner.

Question—put and passed. Resolution to be reported.

The House resumed; Mr. Adermann reported accordingly.

Mr. Holt moved, pursuant to contingent notice, That so much of the Standing Orders be suspended as would prevent the remaining stages being passed without delay.

Question—put and passed.

On the motion of Mr. Holt, the Resolution reported from the Committee was adopted by the House.

Ordered—That Mr. Holt and Mr. McEwen do prepare and bring in a Bill to carry out the foregoing Resolution.

Mr. Holt then brought up the Bill accordingly, and moved, That it be now read a first time.

Question—put and passed.—Bill read a first time.

Mr. Holt moved, That the Bill be now read a second time.

Debate ensued.

Question—put and passed.—Bill read a second time:

Mr. Speaker left the Chair, and the House resolved itself into a Committee of the Whole.

#### (In the Committee.)

Bill, by leave, taken as a whole, and agreed to.

Bill to be reported without amendment.

The House resumed; Mr. Adermann reported accordingly.

On the motion of Mr. Holt, the House adopted the Report, and the Bill was read a third time.

Debate continued.

Mr. Beale (Minister for Supply) moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed.

Ordered-That the resumption of the debate be made an Order of the Day for the next sitting.

9. Adjournment.—Mr. Beale (Minister for Supply) moved, That the House do now adjourn. Debate ensued.

Question—put and passed.

And then the House, at twenty minutes to eleven o'clock p.m., adjourned until to-morrow at half-past ten o'clock a.m.
