3. Customs Tariff Re-adjustment.—Mr. Hume Cook moved, pursuant to notice, That, in the opinion of this House, the existing Customs Tariff is unscientific in its operation and mischievous in its effects; and that, with a special view to the promotion of the agricultural and manufacturing industries and the more settled employment of all classes of workers, a re-adjustment of its incidence on some of its leading lines is highly desirable.
