- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. PRIVILEGE—REFLECTION ON HOUSE COMMITTEE.—Mr. Speaker drew the attention of the House to a statement in the Sydney newspaper Daily Telegraph of the 18th October, 1951, concerning an alleged criticism by the Prime Minister at a party meeting of a decision of the Joint House Committee to restrict the use of the Parliamentary Refreshment Rooms. Mr. Speaker laid upon the Table a copy of the paper containing the statement and showing the name of the printer and publisher.

Mr. Menzies (Prime Minister), made a Statement in connexion with the matter.

Mr. Evatt (Leader of the Opposition), as a matter of Privilege, moved, That the statement in the news-paper be referred to the Committee of Privileges for report.

Question-put and passed.

- 3. JOINT HOUSE COMMITTEE-DECISION TO RESTRICT USE OF PARLIAMENTARY REFRESHMENT ROOMS-STATEMENT BY MR. SPEAKER .-- Mr. Speaker informed the House of certain decisions of the Joint House Committee to restrict the use of the Parliamentary Refreshment Rooms.
- 4. COPPER-MINISTERIAL STATEMENT.-Mr. Beale (Minister for Supply), by leave, made a Ministerial Statement regarding Australian requirements of copper and discussions at the International Materials Conference, Washington, concerning supplies.
- 5. NATIVE WELFARE-REPORT OF CONFERENCE-MINISTERIAL STATEMENT-MOTION FOR PRINTING PAPERS.-Mr. Hasluck (Minister for Territories), by leave, made a Ministerial Statement informing the House of the results of a Conference on Native Welfare held at Canberra, 3rd and 4th September, 1951, by Commonwealth and State Ministers. Mr. Hasluck then, by command of His Excellency the Administrator of the Government of the Commonwealth, laid upon the Table the following Papers :-

9. FOREIGN AFFAIRS-PROPOSED JOINT COMMITTEE.-The Order of the Day having been read for the resumption of the debate on the following motion of Mr. Casey (Minister for External Affairs) :-

- (1) That a Joint Committee be appointed to consider such matters concerning foreign affairs as are referred to it by the Minister for External Affairs. (2) That twelve Members of the House of Representatives be appointed to serve on such
- Committee.
- (3) That the Minister for External Affairs shall make available to the Committee information within such categories or on such conditions as he may consider desirable.
- (4) That, notwithstanding anything contained in the Standing Orders-
 - (a) the Committee have power to appoint sub-committees consisting of four or more of its members; and to refer to any such sub-committee any of the matters which the Committee is empowered to examine;
 - (b) the Committee or any sub-committee have power to sit during any adjournment of the Parliament and during the sittings of either House of the Parliament;
 - (c) the Committee and its sub-committees will sit in camera and their preceedings shall be secret;

- (d) seven members of the Committee constitute a quorum of the Committee and three members of a sub-committee constitute a quorum of that subcommittee :
- (e) the Committee shall, for considerations of national security, in all cases forward its reports to the Minister for External Affairs, but on every occasion when the Committee forwards a report to the Minister, it shall inform the Parliament that it has so reported :
- (f) the Committee shall have no power to send for persons, papers or records without the concurrence of the Minister for External Affairs and all evidence submitted to the Committee shall be regarded as confidential to the Committee; and
- (g) a message be sent to the Senate requesting its concurrence and asking that seven members of the Senate be appointed to serve on such Committee-

Debate resumed.

Ordered-That the amendments circulated by Mr. Evatt (Leader of the Opposition) be considered together.

Paragraph (1), at end of paragraph add " or by either House of the Parliament or as are decided upon by a majority of the Committee ".

Paragraph (2), at end of paragraph add "six to be Government supporters and six Opposition supporters '

Paragraph (4), at end of sub-paragraph (c) add " unless the Committee or sub-committee otherwise orders

Paragraph (4), at end of sub-paragraph (e) add " and either House of Parliament may decide that the report be published ".

Paragraph (4), omit sub-paragraph (f), insert the following sub-paragraph :—" (f) the Committee shall have power to send for persons, papers or records".
