Eggins, and moved, That this House expresses its deep regret at the death of Mr. Eldred James Eggins, who at the time of his death was Member for the Division of Lyne in the House of Representatives, and was formerly a member of the New South Wales Legislative Council, places on record its appreciation of his meritorious public service, and tenders its profound sympathy to his widow and family in their bereavement.
