- 1. The House met, at half-past ten o'clock a.m., pursuant to adjournment.-Mr. Speaker (the Honorable A. G. Cameron) took the Chair, and read Prayers.
- 2. ADJOURNMENT-MOTION FOR PURPOSE OF DISCUSSION.—Mr. Peters proposing to move the adjournment of the House for the purpose of discussing a definite matter of urgent public importance, namely, "The increased volume and cost of importations permitted by the Government which has caused unemployment in the manufacturing industries and a serious reduction in our overseas funds
  - Mr. Speaker called upon those Members who approved of the proposed discussion to rise in their places, and more than the necessary number of Members having risen accordingly-
  - Mr. Peters moved, That the House do now adjourn.

Ordered-That Mr. Peters be granted an extension of time.

Debate ensued.

Ordered-That Mr. Eric J. Harrison (Minister representing the Minister for Trade and Customs) be granted an extension of time.

- Debate continued.
- The debate having been continued for two hours, it was terminated in accordance with Standing Order No. 92.
- 3. ORDER OF THE DAY NO. 1-SUPPLY ["GRIEVANCE DAY"].-It being past fifteen minutes to one o'clock p.m., Order of the Day No. 1 ("Grievance Day"-pursuant to Standing Order No. 291) was not called on, and the Committee of Supply was set down for the next sitting.
- 4. WAR SERVICE HOMES-MINISTERIAL STATEMENT-MOTION FOR PRINTING PAPER.-Mr. Townley (Minister for Social Services), by leave, made a Ministerial Statement concerning the deferment of assistance under the War Service Homes Act for the purchase of existing properties which are other than newly-constructed homes. Mr. Townley then, by command of His Excellency the Governor-General, laid upon the Table the following Paper :--

(3.) There is payable to the Whip in the House of Representatives of each recognized

"(3.) There is payable to the Whip in the House of Representatives of each recognized political party which has not less than ten members in that House, but not including the Government Whip, an allowance at the rate of Two hundred and seventy-five pounds a year.".

Clause, as amended, agreed to.

- 20. FOREIGN AFFAIRS-JOINT COMMITTEE-SENATE'S MESSAGE NO. 77.-The Order of the Day having been read for the consideration of the Senate's Message No. 77 requesting the concurrence of the House in the Senate's modifications of the resolutions transmitted to the Senate by the House for the appointment of a Joint Committee to consider such matters concerning foreign affairs as are referred to it by the Minister for External Affairs-

The House proceeded to consider the Senate's modifications, which are as follows :---

- (a) that after resolution No. 2 the following resolution be inserted : "That the persons appointed for the time being to serve on the Committee shall constitute the Committee notwithstanding any failure by the Senate or the House of Representatives to appoint the full number of Senators or Members referred to in these resolutions."
- (b) that the following provision for quorums be substituted for resolution No. 4(d):
  - (d) (i) one-third of the number of members appointed to the Committee for the time being constitute a quorum of the Committee, save that where the number of members is not divisible by three without remainder the quorum shall be the number next higher than one-third of the number of members for the time being;

(ii) three members of a sub-committee constitute a quorum of that sub-committee.". On the motion of Mr. Casey (Minister for External Affairs), the modifications were agreed to, after debate.

21. SECURITY TREATY (AUSTRALIA, NEW ZEALAND AND THE UNITED STATES OF AMERICA) BILL 1952 .-The Order of the Day having been read for the resumption of the debate on the question, That the Bill be now read a second time-

Debate resumed.

Mr. Graham moved, That the debate be now adjourned.

Question—That the debate be now adjourned—put and passed. Ordered—That the resumption of the debate be made an Order of the Day for the next sitting.

22. ADJOURNMENT.--Mr. Casey (Minister for External Affairs) moved, That the House do now adjourn. Debate ensued. Ordered-That Mr. C. R. Cameron be granted an extension of time. Debate continued.

Question—put and passed.
