- 9. SUPPLY-BUDGET DEBATE.-The House, according to Order, resolved itself into the Committee of . Supply.

General debate resumed on the question, That the first item in the Estimates, under Division No. 1-Senate-namely-

Salaries and allowances £13,500

be agreed to.

Mr. Evatt (Leader of the Opposition) moved, as an amendment, That the first item be reduced by $\pounds 1$. Debate continued.

Progress to be reported, and leave asked to sit again.

The House resumed ; Mr. Bowden reported accordingly. Resolved—That the House will, at the next sitting, again resolve itself into the said Committee.

- ADJOURNMENT.—Mr. McMahon (Minister for the Navy) moved, That the House do now adjourn. Debate ensued. Question—put and passed.
- And then the House, at twenty-six minutes to twelve o'clock midnight, adjourned until to-morrow at half-past two o'clock p.m.
