APPOINTMENT OF FIELD-MARSHAL SIR WILLIAM SLIM, G.C.B., G.B.E., D.S.O., M.C., AS GOVERNOR-GENERAL—MINISTERIAL STATEMENT.—Mr. Menzies (Prime Minister) informed the House that he had received advice that Her Majesty The Queen had been pleased to approve of the appointment of Field-Marshal Sir William Slim, G.C.B., G.B.E., D.S.O., M.C., as Governor-General of the Commonwealth of Australia. Mr. Menzies also informed the House that the present Governor-General of the Commonwealth of Australia. General would continue in office until Sir William Slim is sworn in; it was anticipated that Sir William Slim would leave for Australia early in the New Year.
